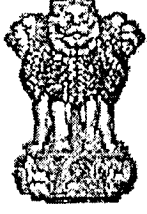

Reference is invited to the Department of Higher Education, Ministry of Human Resource Development DO No. 6-2/2017-UIA dated 10/04/2017, which reads as follows:
